AN ORDINANCE TO PROVIDE AN EASEMENT TO  
BEVIL OAKS MUNICIPAL UTILITY DISTRICT  
TO LAY SEWER LINES IN ALL STREETS, RIGHTS-OF-WAY  
AND EASEMENTS OWNED AND/OR CONTROLLED BY  
THE TOWN OF BEVIL OAKS

WHEREAS, the Mayor and Board of Aldermen of the Town of Bevil Oaks, Texas, find it necessary to provide an easement to BEVIL OAKS MUNICIPAL UTILITY DISTRICT, a municipal utility district operating under Chapter 54 of the Texas Water Code, of Jefferson County, Texas, to lay sewer lines in all streets, rights-of-way and easements owned and/or controlled by the Town of Bevil Oaks; and

WHEREAS, the Mayor and Board of Aldermen of the Town of Bevil Oaks, Texas, desire to put into effect such conveyance by the execution of an instrument granting such easement to BEVIL OAKS MUNICIPAL UTILITY DISTRICT:

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF BEVIL OAKS:

That the TOWN OF BEVIL OAKS, TEXAS, grants unto BEVIL OAKS MUNICIPAL UTILITY DISTRICT, an easement to lay sewer lines in all streets, rights-of-way and easements owned and/or controlled by the Town of Bevil Oaks, together with all other rights necessary to construct, maintain, operate, repair, replace and/or remove such sewer lines, as may be required by BEVIL OAKS MUNICIPAL UTILITY DISTRICT from time to time, and for so long as the said BEVIL OAKS MUNICIPAL UTILITY DISTRICT operates and maintains such sewer system, or until the said easement is relinquished or abandoned, and the Mayor and Secretary are further authorized to execute all necessary instruments necessary to order to effectuate said conveyance, and the Secretary is hereby further authorized to affix the seal of the Town of Bevil Oaks in order to consummate said easement.
